

We now more fully understand that responsibility for health literacy extends beyond individuals to include the organizations and professionals who create and deliver health information and services. Health literacy occurs when a society provides accurate health information and services that people can easily find, understand, and use to inform their decisions and actions

- Doing [*Praxis*]


From Paulo Freire

- Theory alone is insufficient: without practice there is no knowledge
- Action alone is insufficient: Without knowledge, action can be chaotic

Redefines praxis in *Pedagogy of the Oppressed* as an ongoing cycle of reflection and action directed at the structures to be transformed

Common Visual of Interaction



Some Issues

13

- Time
- Questions to be explored and solutions to be tested were not collaboratively generated
- Research focus and findings did not yield guidance for practice or policy action

- Community based practitioners / agencies lack the structural support needed for collaboration
- Follow-up in community was not a priority

- Poor communication: jargon calls for plain language translation
- Strategic arguments for stakeholders were lacking
